

If you feel you need additional training, please speak with your Supervisor about receiving additional training or assistance. There are a few spaces available in the remaining training classes. Kimberly Haines and Leslie Pegram are also available to sit one-on-one to discuss your current workflow and how Epic will integrate into your current process.

Thank you to the 118 staff members' log-ins we were able to test during "Epic Log-In Days" on December 21 & 22. We will be testing log-ins again on January 4<sup>th</sup> from 11am-1pm and January 9<sup>th</sup> from 7am-9am (both in the Scheduling Conference Room). Each step in the Epic process is important to make for a successful transition.

We will have a process in place for Radiology staff members if problems arrive the first few weeks after go-live. We will have 24 hour coverage by Supervisors and Super Users from January 21<sup>st</sup> to February 6<sup>th</sup>. Names and phone numbers will be posted prior to go-live.

Our Radiology department is very prepared for this transition. Look for more information throughout the month regarding important updates and information prior to go-live





# CHAIRMAN'S CORNER Barry McCook, MD

With the beginning of a new year, one spends some time on making resolutions and goals. These are some of the resolutions and goals for the department for 2012:


- Installation of the new MRI scanner in the Clinical Center

#### PATIENT SAFETY 101: Radiation Dose Reduction

As part of our departments initiative to reduce radiation dose to our patients (as suggested by the Joint Commission's Sentinel Event alert), Jeff Stiles has created a course in HealthStream for Technologists titled "Introduction to Computed Radiography." Completion of this course by all Diagnostic Technologist is required by December 31<sup>st</sup>. One CEU is provided by the Florida Department of Health after completion of this course.

On December 23<sup>rd</sup>, Dr. Paul Wasserman and Leslie Pegram submitted a proposal titled "Reduction of Ionizing Radiation during Pediatric, Portable, DR and CT Imaging" for a Clinical Quality Award. This project is slated to begin February 1, 2012. It will last one year and hopefully yield significant reductions in radiation dose to our patients. 
## SCHOOL OF RADIOLOGIC TECHNOLOGY

These images show severe, chronic destructive changes throughout the entire knee joint. The joint exhibits sclerosis and lucencies which are likely secondary to extensive bone infarcts/AVN. These images also present the possibility of infection or osteomyelitis.

#### FY12 Results (As of 12/28/11)

\* SJMC's Overall Quality of Care goal for FY12 is the 75<sup>th</sup> percentile. Numbers below are based on percent excellent rankings, as compared to the PRC norm.

- SJMC Inpatient Overall Quality of Care: 56.8%
- SJMC ED Overall Quality of Care: 35.9%
- SJMC Outpatient Surgery Overall Quality of Care: 30.9%
- SJMC Radiology Inpatient Overall Quality of Care: 63.9%
- SJMC Radiology ED Overall Quality of Care: 66.9%

**Key Words at Key Times:** Things said and done to "connect the dots" and help patients, families, and visitors better understand what we are doing and why. They align our words with our actions to give a consistent experience and message.

- Privacy: "I am closing this curtain for your privacy." or "Let me cover you for your privacy."
- <u>Safety:</u> "For your *safety*, it is important that I verify your name and date of birth and view your wristband before beginning this procedure." "I am using hand gel for your *safety* and mine. The foam hand sanitizer is available for you and your family to use as well."
- <u>Duration</u>: "This test usually takes *about 90 minutes*. I will explain the procedure to you so you will know what to expect."
- <u>Wait Time (angry patient)</u>: "I'm sorry your wait is long. Is there anything I can do to make you more comfortable? I appreciate you bringing the wait to my attention. Thank you for your patience."
